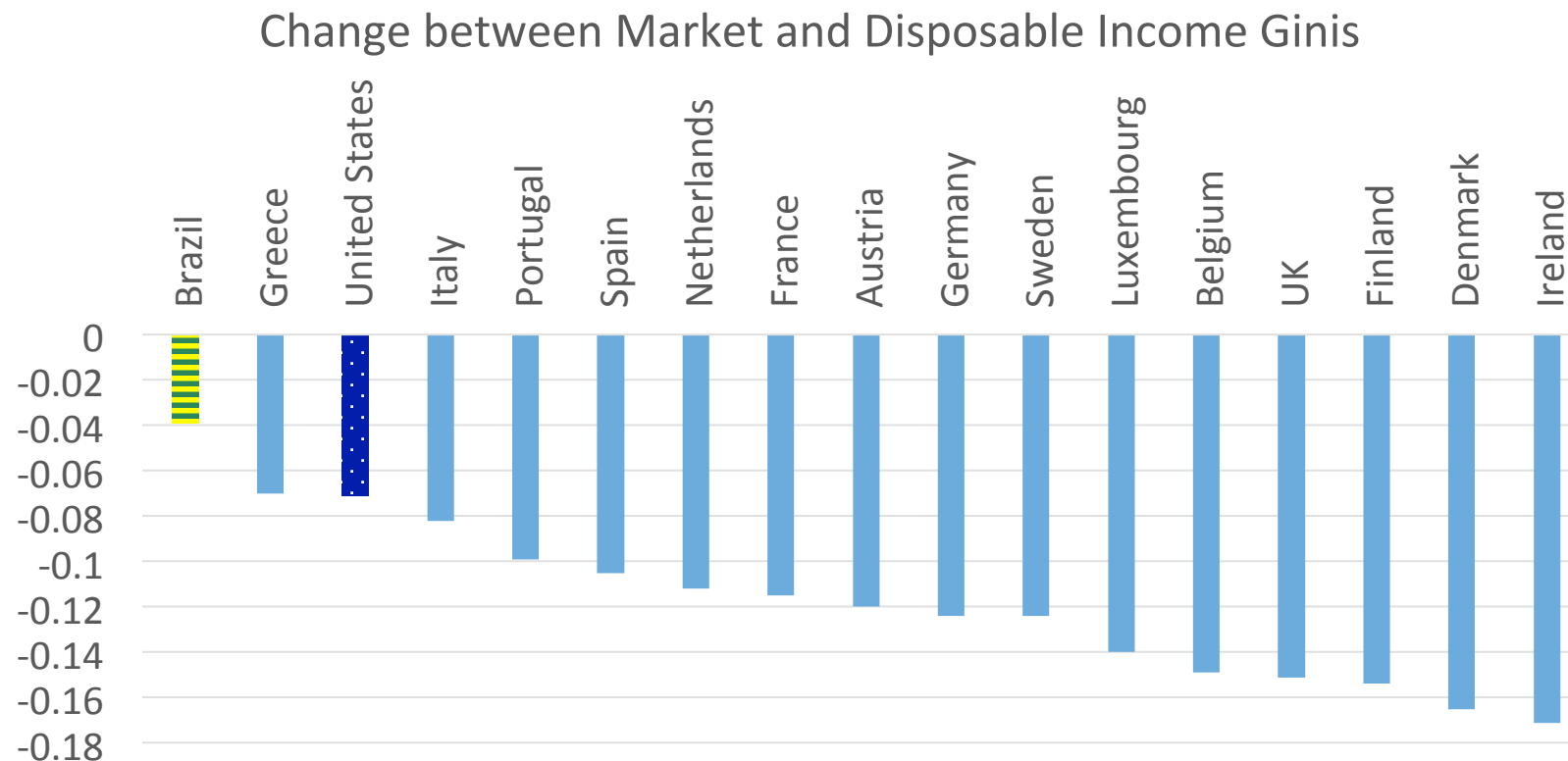

Inequality Reduction by Direct Taxes and Transfers: Brazil, Europe and US

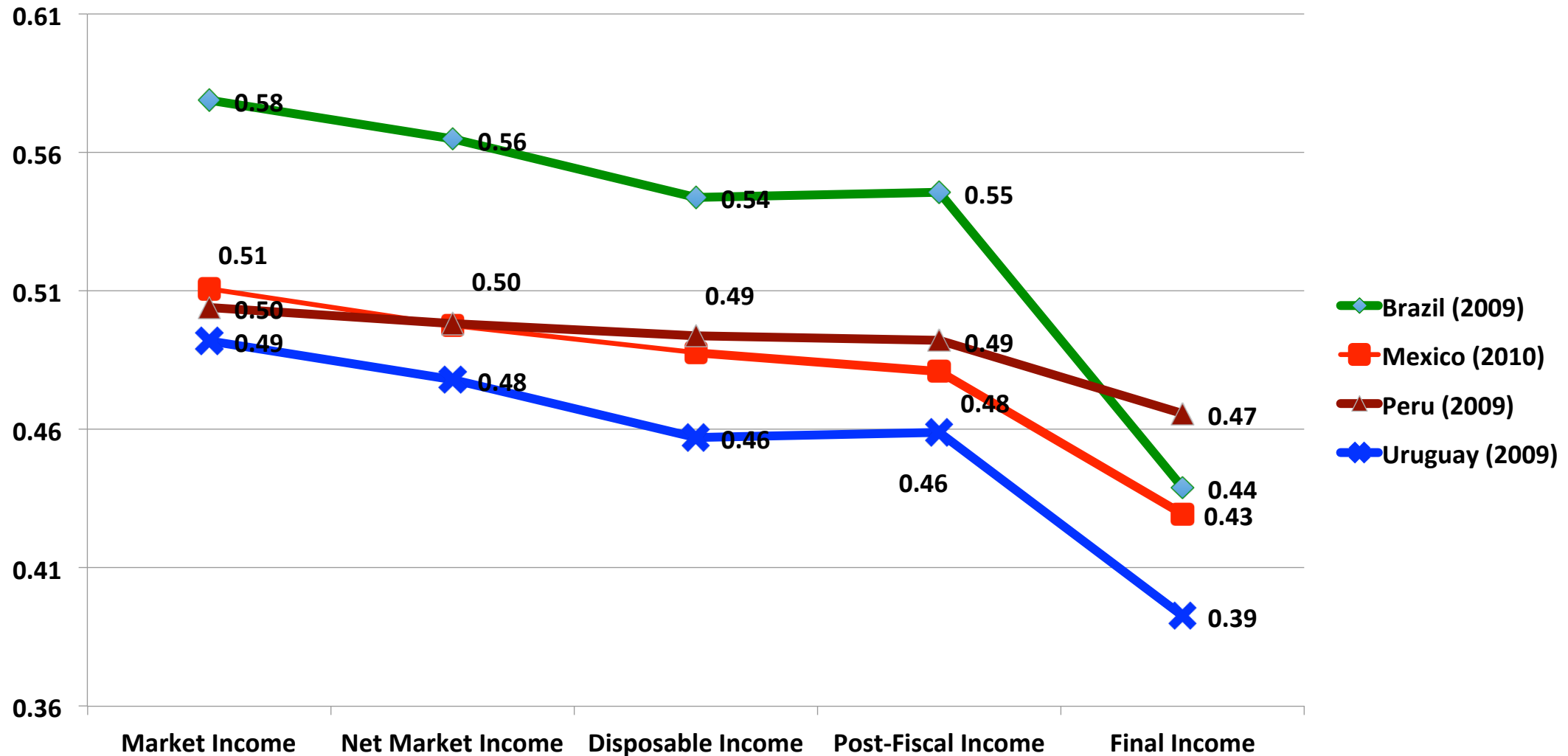
- Direct taxes and transfers reduce inequality by
 - 7.0 percentage points in US
 - 3.9 percentage points in Brazil

Inequality Reduction: Brazil, Mexico, Peru and Uruguay (2009)

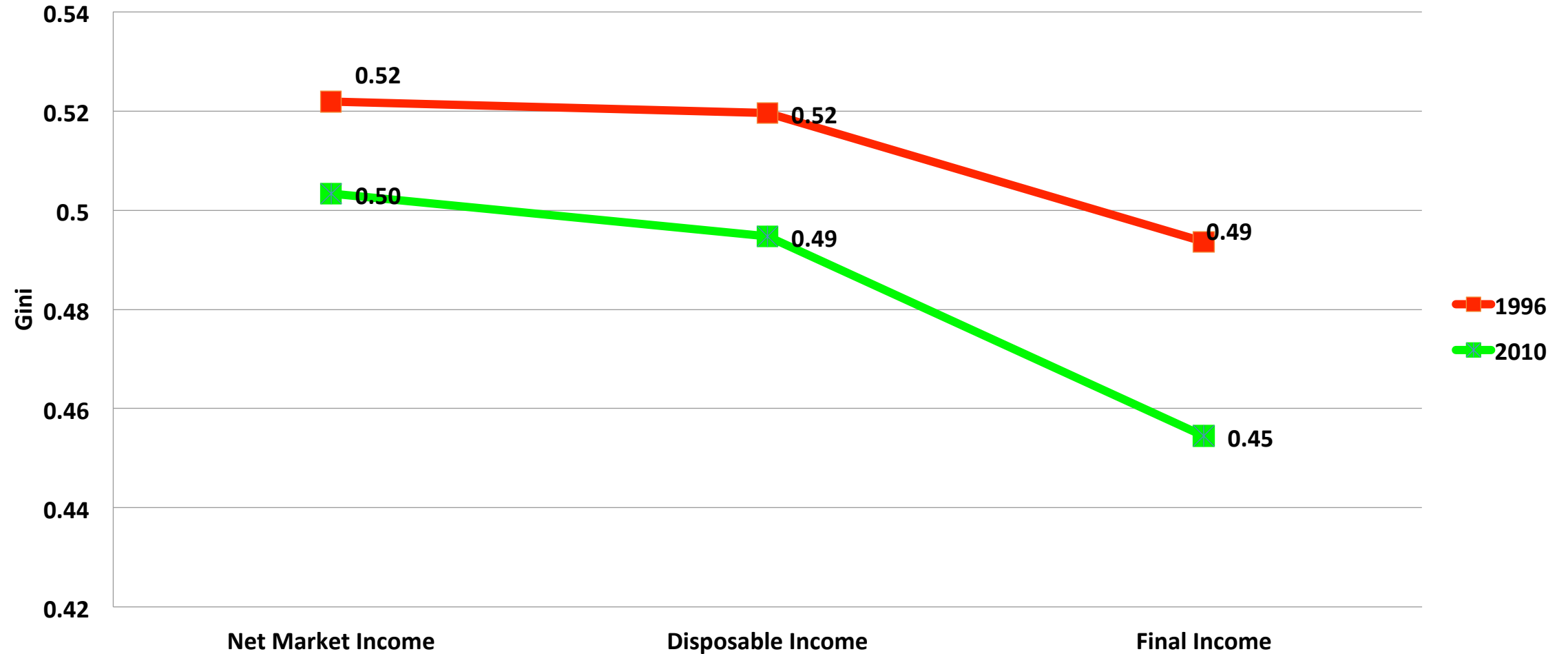
(Taxes and Social Spending)
